## 1. PURPOSE OF THE MoU

This MoU will help to

- Organize seminars and workshops related to aquaculture and shrimp farming.
- Conduct practical trainings for the students.
- Organize the field trips along with Aquaculture experts
- Assist the students in establishing various start-ups
- Help the students to have an in-depth knowledge on the related field of aquaculture

## 2. SCOPE OF THE MoU

- Both **TBMLC** and **SHRIMP CARE SOLUTIONS** shall encourage interactions between the Scientists, Research fellows, Faculty members and Students of the organizations through the following arrangements:
- Exchange of personnel through deputation as per the rules of the respective institute, for limited periods as mutually agreed upon.
- Organization of joint Conferences and Seminar.
- Practical training of **TBMLC** students at **SHRIMP CARE SOLUTIONS**.
- Joint guidance of student Projects/Thesis and in other areas of National interest at **TBMLC** by **SHRIMP CARE SOLUTIONS** on mutually agreeable terms.
- **SHRIMP CARE SOLUTIONS** may depute its personnel as Visiting Faculty at **TBMLC** to teach specialized topics.
- **SHRIMP CARE SOLUTIONS** may seek Assistance/Guidance of **TBMLC** Faculty member/s in Product/Process modification, Troubleshooting etc.,
- This would allow the visits of students to **SHRIMP CARE SOLUTIONS** to provide them with an exposure to various equipments, instruments, etc.,
- **SHRIMP CARE SOLUTIONS** may showcase its business activities at the Seminar/Workshop/Conference etc. at **TBMLC**.
- **SHRIMP CARE SOLUTIONS** may avail Library, Internet, Computational facilities at **TBMLC**.
- Post - Graduate student will be allotted a Research Supervisor from **TBMLC** Faculty members and the student may be encouraged to take up the project in **SHRIMP**



**CARE SOLUTIONS** with the Research & Development Department in this Institution.

- Students can carry out part of their Ph.D., Research work or M.Phil./M.Sc., Project at **TBMLC** and **SHRIMP CARE SOLUTIONS** depending on the nature of the work as per rules of the Respective Institute depending on Facilities and Requirements.
- There will be no restriction on the contents of the Thesis and on Publication of results of the thesis, subject to the condition that no Intellectual Property Rights can be secured for any part of the work which will be decided with mutual consent.
- Both **TBMLC** and **SHRIMP CARE SOLUTIONS** will be free to independently carry out follow-up research on the thesis work conducted under this scheme.
- If the outcome of a project related to product development, process technology and design etc., which involves matter of secrecy and concern with security of the State and the Country, the same will not be allowed for publication/printing in any form such as Electronical / Verbal, etc. If the outcome of a project results into an intellectual property, for which rights can be secured, it will be decided on case to case basis. Similarly, sharing of expenditure in securing such rights and income accrued through royalty etc., by the parties under the law will be decided on case to case basis after mutual consultation.
- Research supervisors from both the Institutes will be the corresponding authors in any publication resulting from the collaborative work. All the efforts put by the student's as a part of this MoU will be accounted for by way of reporting the work in thesis and/or paper publication except the part for claimed.
- Neither of the supervisors will publish the work carried out under this MoU without knowledge of the other.
- In any of the activities mentioned above, wherever financial aspects are involved, amount, payment conditions, etc. would be spelt out clearly before starting the activity.

### **3. SHARING OF FACILITIES**

- **TBMLC** and **SHRIMP CARE SOLUTIONS** shall make provisions to share their respective important R&D facilities in order to promote academic and research interactions.
- **TBMLC** and **SHRIMP CARE SOLUTIONS** shall permit the sharing of software and other materials and components developed in house in the areas of cooperation, if permissible within the rules governing the two institutions. However, responsibility

for safety of software and other materials during the exchange will rest on respective Head of academic department/section.

- **TBMLC and SHRIMP CARE SOLUTIONS** shall provide access to the library facilities to Scientists, Members of Faculty and Students as per the prevailing rules and norms in the respective institutes.

#### **4. CO-ORDINATION OF THE PROGRAMME INCLUDING FINANCIAL ARRANGEMENTS**

- The collaborative programme between **TBMLC** and **SHRIMP CARE SOLUTIONS** shall be coordinated by a coordination committee appointed by Authorities of both the Institutes.
- Financial arrangements for each specific collaboration will be decided on a case- to-case basis and brought on record in each case after due approval from Heads of both the Institutions.

#### **5. VALIDITY**

- The validity of the agreement is **FIVE** years from the date of agreement.
- Both Parties may terminate this MoU upon 30 calendar days notice in writing. In the event of Termination, both parties have to discharge their obligations.
- Any dispute will be settled amicably by negotiation between two parties.

## PREAMBLE

Whereas, Tranquebar Bishop Manikam Lutheran College Porayar 609 307(TBMLC) at Physics department is charged with responsibility of training technical and scientific manpower in various front-line areas of importance for the Nation and is also contributing to the rapidly growing scientific and technological knowledge and professional excellence in Science & Technology by undertaking industrial & applied research and consultancy.

WHEREAS, INTECH is engaged in hardening of materials, design and development and consultancy in the field of Material Science and related fields.

WHEREAS, both TBMLC and INTECH, now

- Recognizing the importance of research and development in the field of Material Science, as well as imparting industrial training to the engineering/technology/sciences students, etc.
- Appreciating the need for creation of large reservoir of highly qualified manpower in all fields related to industries
- Desiring to club their efforts by pooling their expertise and resources,

INTEND to form a nucleus for promoting excellent quality manpower in the fields of engineering, technology and sciences with special emphasis on Material Science and related fields etc.

NOW, THEREFORE, in consideration of the mutual promises made herein and of good and valuable consideration, the receipt and sufficiency of which both TBMLC and INTECH hereby acknowledge, TBMLC and INTECH hereby agree to sign a memorandum of understanding (MoU).

### ARTICLE-I: SCOPE OF THE MOU

This MOU details the modalities and general conditions regarding collaboration between TBMLC and INTECH for enhancing, within the country, the availability of highly qualified manpower in the areas of Material Science without any prejudice to prevailing rules and regulations in TBMLC and INTECH without any disregard to any mechanism evolved and approved by the competent authorities under Govt. of India in so far as such mechanism applies to TBMLC and INTECH. The areas of cooperation can be extended through mutual consent.



## ARTICLE-II: SCOPE AND TERMS OF INTERACTIONS

Both TBMLC and INTECH shall encourage interactions between the Engineers, Scientists, Research fellows, faculty members and students of both the organizations through the following arrangements:

- a) Exchange of personnel through deputation as per the rules of the respective institute, for limited periods as mutually agreed upon;
- b) Organization of joint conferences and seminars;
- c) Practical training of TBMLC students at INTECH;
- d) Joint guidance of student projects/thesis in science and other areas of national interest at TBMLC by INTECH on mutually agreeable terms.
- e) INTECH would accommodate B.Sc/M.Sc Physics students who have completed the 6<sup>th</sup>/4<sup>th</sup> semester of their programme in such a number that INTECH deems convenient to it for the purpose of imparting industrial training.
- f) INTECH may depute its personnel as visiting faculty at TBMLC to teach specialized topics.
- g) INTECH personnel, as well as research scholars, may also be allowed to enroll for their Ph.D./M.Phil. (Research) at TBMLC, subject to availability of seats, research facilities and subject to their fulfilling eligibility criteria and all other academic regulations of TBMLC. Further, INTECH may request to design and teach a Course or Courses which it deems fit to enhance quality and performance of its employees. Such Courses maybe run at any mutually convenient premises.
- h) INTECH may seek assistance/guidance of TBMLC faculty member/s in product/process modification, modernization, trouble shooting, etc.
- i) Would allow the industrial visits of students for half/full day to provide them with an exposure to various equipment, instrument, etc.
- j) INTECH may showcase its business activities at the seminar/workshop/conference, etc. at TBMLC.
- k) INTECH may avail library, Internet, computational facilities at TBMLC.
- l) Post-graduate student will be allotted a Research supervisor from TBMLC faculty members. The student maybe encouraged to take up the project such that INTECH desirably benefits from its outcomes.
- m) Students can carry out part of their Ph.D. research work or M.Phil./M.Sc. project at TBMLC and INTECH depending on the nature of the work as per rules of the respective institute depending on facilities and requirements.
- n) There will be no restriction on the contents of the thesis and on publication of results of the thesis, subject to the condition that no Intellectual Property Rights can be secured for any part of the work which will be decided with mutual consent.
- o) Both TBMLC and INTECH will be free to independently carry out follow-up research on the thesis work conducted under this scheme





- p) If the outcome of a project related to product development, process technology and design etc. which involves matter of secrecy and concern with security of the State and the Country, the same will not be allowed for publication/printing in any form such as Electronical/verbal, etc. If the outcome of a project results into an intellectual property, for which rights can be secured, it will be decided on case to case basis. Similarly, sharing of expenditure in securing such rights and income accrued through royalty etc by the parties under the law will be decided on case to case basis after mutual consultation.
- q) Research supervisors from both the Institutes will be the corresponding authors in any publication resulting from the collaborative work. All the efforts put by the student/s as a part of this MoU will be accounted for by way of reporting the work in thesis and/or paper publication except the part for which IPR needs be claimed.
- r) Neither of the supervisors will publish the work carried out under this MoU without knowledge of the other.
- s) In any of the activities mentioned above, wherever financial aspects are involved, amount, payment conditions, etc. would be spelt out clearly before starting the activity.

#### ARTICLE-III : SHARING OF FACILITIES

- a) TBMLC and INTECH shall make provisions to share their respective important R&D facilities in order to promote academic and research interaction in the areas of cooperation.
- b) TBMLC and INTECH shall permit the sharing software and other materials and components developed in-house in the areas of cooperation, if permissible within the rules governing the two institutions. However, responsibility for safety of software and other materials during the exchange will rest on respective Head of academic department/section.
- c) TBMLC and INTECH shall provide access to the library facilities to scientists, members of faculty and students as per the prevailing rules and norms in the respective institutes.

#### ARTICLE-IV: CO-ORDINATION OF THE PROGRAMME INCLUDING FINANCIAL ARRANGEMENTS

- a) The collaborative programme between TBMLC and INTECH shall be coordinated by a coordination committee appointed by authorities of both the Institutes.
- b) Financial arrangements for each specific collaboration will be decided on a case- to-case basis and brought on record in each case after due approval from heads of both the Institutions.

#### ARTICLE-V : EFFECTIVE DATE AND DURATION OF MOU

- a) This MOU shall be effective from the date of its approval by competent authorities at both ends.
- b) The duration of the MOU shall be for a period of 5 years from the effective date.
- c) During its tenancy, the MOU may be extended or terminated by a prior notice of not less than six months by either party. However, termination of the MOU will not in any manner affect the interests of the students/faculty/scientists who have been admitted to pursue a programme under the MOU.



- d) Any clause or article of the MOU may be modified or amended by mutual agreement of INTECH and TBMLC.

#### ARTICLE-VI : IPR

Rights regarding publications, patents, royalty, ownership of software/design/product developed etc. under the scope of this MOU, shall be decided by the two parties by mutual consent.

#### ARTICLE-VII: CONFIDENTIALITY

During the tenure of the MOU both TBMLC and INTECH will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any purpose other than in accordance with this MOU.

Both TBMLC and INTECH shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of the disclosing party or use such confidential information for any use other than intended under this agreement or PROJECTS.

Further both TBMLC and INTECH shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.

CONFIDENTIAL INFORMATION shall mean any proprietary information, data or facts belonging to PARTIES collectively or severally, disclosed by the disclosing party under this agreement or any subsequent agreement, whether in writing, verbal or electronically, irrespective of the medium in which such information is stored, which is marked confidential or with any other words having similar meaning by the disclosing party, or specifically agreed to be kept confidential by the parties, or declared or identified so by the disclosing party before such disclosure or during the discussions. However confidential information shall not include any data or information which:

- (a) Is or becomes publicly available through no fault of the receiving party,
- (b) Is already in the rightful possession of the receiving party prior to its receipt of such data or information;
- (c) Is independently developed by the receiving party without reference to the confidential information of the disclosing party
- (d) Is rightfully obtained by the receiving party from a third party or is in the public domain
- (e) Is disclosed with the written consent of the party whose information it is, or
- (f) Is disclosed pursuant to court order or other legal compulsion, after providing prior notice to the disclosing party.

#### ARTICLE-VIII : AMENDMENTS

Any amendment and/or addenda to the AGREEMENT shall be in writing and signed by the PARTIES hereto and shall only after such execution be deemed to form part of the AGREEMENT and have the effect of modifying the AGREEMENT to the extent required by such amendment or addenda.





ARTICLE-IX : RESOLUTION OF DISPUTES

- a) This agreement shall take effect and be construed in accordance with the Laws of India and be subject to the jurisdiction of the court at Mayiladuthurai.
- b) The dispute or difference whatsoever arises between PARTIES in relation to or in connection with this AGREEMENT both the parties shall first try to resolve the dispute/difference amicably between them, failing which the matter shall be referred to and settled through arbitration. The arbitration proceedings shall be held in accordance with the provision of Indian Arbitration and Reconciliation ACT, 1996. The venue of arbitration shall be New Delhi and Language of arbitration shall be English.

ARTICLE-X: MISCELLANEOUS


- a) The headings and sub-headings are inserted for convenience only and shall not affect the construction of this Agreement.
